Export quarantine certificate for Beef from Japan to Australia (Attachment 1)

I, the undersigned animal quarantine officer, hereby certify that:

1. The meat exported to Australia is derived exclusively from bovine skeletal muscle* and contains no lymphatic or other tissues.
** Skeletal muscle includes any attached rind, fat, connective tissue, nerve, blood and blood vessels.*
2. Japan is free from Brucellosis (*Brucella melitensis*), Contagious bovine pleuropneumonia, Crimean–Congo haemorrhagic fever, Foot-and-mouth disease (without vaccination), Haemorrhagic septicaemia, Rift Valley fever, Surra (*Trypanosoma evansi*), Theileriosis (*Theileria annulata* and *T. parva*), Trypanosomiasis (*Trypanosoma congolense*, *T. vivax* and *T. brucei*) and Wesselsbron disease.
3. The bovine spongiform encephalopathy (BSE) risk status of Japan is currently recognised by Food Standards Australia New Zealand (FSANZ) as a Category 1 country.
4. The cattle from which the meat was derived have been kept continuously since birth in Japan.
5. The meat was derived from *Bos taurus* or *Bos indicus* only.
6. The meat is derived from cattle that have been born, raised and slaughtered in Japan and that passed ante-mortem inspection by an official veterinarian and post-mortem veterinary inspection under official veterinary supervision. The meat is fit for human consumption.
7. The meat does not include brain or any pulmonary or reproductive organs or udders (and associated lymph nodes).
8. Every establishment where the cattle, from which the meat was derived, were slaughtered and where the meat was prepared for export to Australia, has current approval from and is under the supervision of the Ministry of Health, Labour and Welfare of Japan.
9. Official veterinarians were present throughout the slaughtering and processing chains at all times when cattle were being slaughtered and meat processed for export to Australia.
10. The establishment where the meat and meat product was prepared has a Quality Assurance (QA) program under official oversight that includes an approved Codex Alimentarius HACCP based food safety program to control food safety risks, including risks associated with Shiga toxigenic *Escherichia coli* (STEC) and *Salmonella* spp. The QA

program underpins the integrity of meat in each consignment.

11. The establishment/s where the meat was prepared and/or processed did not prepare or process meat not eligible for export to Australia while meat was being prepared and/or processed for export to Australia.
12. The meat for Australia was processed and stored separately from all other products and remained within Japan at all times until export.
13. The meat was not exposed to contamination prior to export.
14. The meat has been packed in clean, new bags, wrappers or packing containers.
15. The meat is being shipped to Australia in a clean container, the seal of which is intact at the time of export and the container contains only commodities eligible for entry to Australia.
16. The meat does not contain material derived from any other animal species.
17. The veterinary approval numbers of the establishment at which the animals from which the meat was derived were slaughtered and the cutting-up establishment at which the meat was prepared are readily visible on the meat or, where the meat is wrapped or packaged, has been marked on the wrapping or packaging containing the meat so that the numbers cannot be readily removed without damaging the meat, and/or the wrapping, and/or the packaging.
