- (ii) The poultry eggs were safely produced at the farm above mentioned under the control of relevant competent authorities of Japan and are therefore fit for human consumption.
- (iii) The poultry eggs and egg products were produced to comply with the Domestic animal infectious diseases control law, Law Concerning Safety Assurance and Quality Improvement of Feeds, Law on Securing Quality, Efficacy and Safety of Products including Pharmaceuticals and Medical Devices and the Hong Kong legislation and regulations for food safety regarding to harmful substances (including but not limited to chemical hazards and drug residues).
- (iv) The poultry eggs were handled, processed, packed, stored and transported hygienically in compliance with legislation and directives administrated by relevant competent authorities of Japan; in addition, their surfaces were sanitized in accordance with OIE's standard.
- (v) The egg products were produced and packed hygienically, processed to ensure the destruction of avian influenza virus in accordance with OIE's standard, and took the necessary precautions to avoid contact of the commodity with any source of avian influenza virus; therefore fit for human consumption.
