

## Results of "4th Japan-Ukraine Joint Task Force on Revitalization Strategy of Agriculture"

On Friday, August 1, 2025, the Ministry of Agriculture, Forestry and Fisheries of Japan (MAFF) and the Ministry of Economy, Environment and Agriculture of Ukraine (MEEA) held an online meeting of the "4th Japan-Ukraine Joint Task Force on Revitalization Strategy of Agriculture ", to exchange views between relevant ministries, agencies, and companies of both countries for cooperation in agricultural reconstruction in Ukraine.

### 3. Outline of results

(1)At the beginning of the meeting, MAFF proposed that this task force, which had been held jointly with the Ministry of Agricultural Policy and Food, be continued with the MEEA, which was newly established due to the reorganization of ministries and agencies of the Ukrainian government in July 2025, and both sides agreed.

(2)In addition, the MAFF explained that in order to further strengthen and accelerate public-private cooperation for the reconstruction of agriculture in the fields of food and agriculture, support for the reconstruction efforts of Ukraine by private companies will continue this fiscal year as well as the plan to dispatch a public-private mission in the field of food and agriculture to Ukraine this autumn, and exchanged views. MEEA explained that food and agriculture are important sectors for the Ukrainian economy, accounting for 17.6% of GDP and 56% of exports in 2024.

(3)Five Japanese private companies explained the reconstruction efforts planned by each company this fiscal year, and exchanged views.

(4)MEEA said that in order to solve issues in the fields of agriculture and food, it is necessary to introduce Japanese products and technologies, and that by

combining the great agricultural potential of Ukraine with the latest Japanese technologies and innovations, new products will be created and value added will be improved.
